

NOTICE

(Re: Seeking shareholders' written opinion)

To: Shareholders of Hoa Sen Group.

The Board of Directors of Hoa Sen Group seeks for shareholders' vote to approve of the decision of the General Assembly of Shareholders, as follows:

- 1. Respondents: All shareholders as listed on July 28th, 2015.
- 2. Tentative schedule: August 3rd, 2015.
- 3. Approval content (according to the content of the submission no. 45/TTr/HDQT/20 dated July 15th, 2015 of the Board of Directors):
 - 3.1. To approve the investment plan of Hoa Sen Nghe An Plant project and authorize the Board of Directors based on practical conditions to decide the project scale and capital of the project, phases and time of implementation, form of investment, methods of mobilizing investment capital, selection of technology, partners and suppliers as well as perform required legal procedures to implement the project according to the law.
 - 3.2. To approve the plan of conducting pre-feasibility study and feasibility study of the integrated steel mill at economic zone with deep-water seaport and authorize the Board of Directors to research the site, seaport, etc and hire a consultancy firm to assess the project, consult procedures of leasing the land, applying for an investment certificate and investment incentives and conduct the pre-feasibility study and feasibility study, etc. The result shall be reported to the General Assembly of Shareholders at the next meetings.

 - The form send back to Hoa Sen Group prior on August 24th, 2015 (based on post stamp date). The form sent to Hoa Sen Group after the spectified deadline or unsealed will be deemed unqualified.
