- The Company's net revenue of the fiscal year 2023-2024 reached VND 39,272 billion, increase by VND 7,621 billion compared to the same period, corresponds to increasing 24%.
- Gross profit increase by VND 1,203 billion compared to the same period, corresponds to increasing 39%.
