In the second quarter of the fiscal year 2024-2025, separate after-tax profit loss VND 93.8 billion decrease by VND 270 billion compared to the same period (the second quarter of the fiscal year 2023-2024 reached VND 176 billion). The main reason is:

- The gross profit decrease by VND 296 billion compared to the same period, corresponds to decreasing 35%.

- Financial expenses increase by VND 23 billion, corresponds to increasing 55%. In which, interest expenses increase by VND 13.8 billion, corresponds to increasing 48% and realised foreign exchange losses increase by 9.4 billion, corresponds to increasing by 70% compared to the same period.

- General and administration expenses increase by VND 41 billion, corresponds to increasing

63% compared to the same period.

In the first 06 months of the fiscal year 2024-2025, separate after-tax profit loss VND 87.8 billion decrease by VND 271 billion compared to the same period (the first 06 months of the fiscal year) 2023-2024 reached VND 183 billion). The main reason is:

The gross profit in the first 06 months decrease by VND 111 billion compared to the same

period, corresponds to decreasing 7%.

Financial expenses increase by VND 47 billion, corresponds to increasing 52%. In which, interest expenses increase by VND 37 billion, corresponds to increasing 68% and realised foreign exchange losses increase by 10 billion, corresponds to increasing by 28% compared to the same period.

- General and administration expenses increase by VND 70 billion, corresponds to increasing

55% compared to the same period.
