In the third quarter of the fiscal year 2024-2025, separate after-tax profit loss VND 62.4 billion decrease by VND 87.3 billion compared to the same period (the third quarter of the fiscal year 2023-2024 reached VND 149.7 billion). The main reason is:

- The gross profit decrease by VND 240 billion compared to the same period, corresponds to decreasing 24%.
- Interest expenses increase by VND 1.5 billion, corresponds to increasing 4% compared to the same period.
- General and administration expenses increase by VND 27 billion, corresponds to increasing 33% compared to the same period.

In the first 09 months of the fiscal year 2024-2025, separate after-tax profit loss VND 25 billion decrease by VND 358 billion compared to the same period (the first 09 months of the fiscal year 2023-2024 reached VND 333 billion). The main reason is:

- The gross profit in the first 09 months decrease by VND 353 billion compared to the same period, corresponds to decreasing 14%.
- Financial expenses increase by VND 42 billion, corresponds to increasing 27%, In which, interest expenses increase by VND 39 billion, corresponds to increasing 43% compared to the same period.
- General and administration expenses increase by VND 97 billion, corresponds to increasing 46% compared to the same period.
