In fiscal year 2024–2025, consolidated net profit after tax reached VND 735 billion, an increase of VND 220 billion, equivalent to 43% rise compared to the same period. The main reasons are:

- Gross profit increased by VND 256 billion, equivalent to 6% rise year-on-year.
- Selling expenses decreased by VND 236 billion, equivalent to 7% decline year-on-year.
- General and administrative expenses increased by VND 170 billion, equivalent to 34% rise year-on-year.
