Article 1. Amendments and supplements to the Charter are as follows

Clauses 1 and 2 of Article 6 are amended and supplemented as follows:

“Article 6: Charter Capital, Shares and Founding Shareholders:

1. The charter capital of the Company is VND 8,072,627,040,000 (In words: Eight trillion seventy-two billion six hundred twenty-seven million forty thousand Vietnamese dong).

2. The total charter capital of the Company is divided into 807,262,704 (In words: Eight hundred seven million two hundred sixty-two thousand seven hundred four) shares with a par value of VND 10,000 per share.

- Pursuant to the Law on Enterprises No. 59/2020/QH14 issued on June 17th, 2020;
- Pursuant to Resolution No. 01/NQ/ĐHĐCĐ/2026 of the General Meeting of Shareholders at the Annual General Meeting of Shareholders for the fiscal year 2025 – 2026 dated March 7th, 2026;
- Pursuant to the Charter of Hoa Sen Group approved by the General Meeting of Shareholders on January 21st, 2021 and its amendment appendices;
- Pursuant to Decision No. M.3./QĐ/HDQT/2026 of the Board of Directors (“BOD”) dated May 15th, 2026 on the increase of charter capital of Hoa Sen Group.
